Mr. Bernier is a director of Majescor Resources Inc. (TSX-V: MJX) and its wholly-owned subsidiary Simact Alliance Copper-Gold Inc.; the Societe Miniere du Nord-Est (SOMINE SA) a Haitian-registered mining company. He is a registered Geoscientist (P.Geo) and practicing member of the Ordre des geologues du Quebec (OGQ) and the Association of Professional Geoscientists of Ontario (APGO); a registered member of the Canadian Institute of Mining and Metallurgy (CIMM); and he holds a Bachelor of Science Honours degree in Geology from the University of Ottawa as well as a Master of Science in Geological Sciences from McGill University in Montreal.
