PERTH, Feb. 24, 2012 - On February 22 and February 24, 2012 [Marengo Mining Limited](#) (TSX:MRN) (ASX:MGO) (POMSoX:MGO) ("Marengo" or the "Company") issued a total of 60,000 and 100,000 ordinary shares respectively at an issue price of A\$0.125 cents each ("Securities").

## Secondary Trading Exemption

The Corporations Act 2001 (Cwlth), ('The Act') restricts the on-sale of Securities issued without disclosure, unless the sale is exempt under section 708 or 708A. By the Company giving this notice, sale of the Securities noted above will fall within the exemption in section 708A(5) of the Act.

    - i. the assets and liabilities, financial position and performance, profits and losses and prospects of the Company; or
    - ii. the rights and liabilities attaching to the Securities.
