Century has promising iron ore assets and is firmly entrenched in western Quebec and in the prolific iron ore-producing region of the Labrador Trough in eastern Quebec and western Labrador. The Company has two key strategic partners in WISCO International and Minmetals Exploration & Development (Luxembourg) Limited S.à.r.l., both state-owned Chinese companies with the financial and technical resources to assist the Company with funding and technical expertise for the exploration and development of its iron ore projects.

The Company has interests in the following mineral exploration projects located in Quebec and Newfoundland & Labrador:

- The Duncan Lake Project in which the Company currently has a 51% interest with an option to increase to a 65% interest under an option and joint venture agreement with [Augyva Mining Resources Inc.](#) (TSX VENTURE:AUV);
- The Attikamagen Project in which Labec Century has a registered 56% interest and in which it has requested a further 4% interest under the Attikamagen Joint Venture Agreement with [Champion Iron Mines Limited](#) (TSX:CHM). Champion is completing its due diligence investigations with respect to the transfer of the 4% interest;
- The Sunny Lake Project (100% owned by the Company); and
- The Astray, Grenville, Menihék and Schefferville projects acquired from [Altius Minerals Corp.](#) (TSX:ALS) (100% owned by the Company).

The Company's objective is to enhance shareholder value through the development of iron ore projects in Canada and to become a major Canadian iron ore producer. Century Iron's website is: www.centuryiron.com.
