## CFO/COO Summarizes the Benefits, Outlook & Perceived Added Value for Shareholders

NEW YORK, Jan 22, 2013 - [Micron Enviro Systems, Inc.](#) (PINKSHEETS: MSVS), an emerging mining company, announced that Nicola Newmarch, CFO & COO of Micron Enviro Systems and Britannia Mining Plc, a UK based mining development company (recently merged with MSVS -- pending shareholder ratification), was interviewed by The Stock Radio yesterday, Monday, January 21st, 2013.
