

GoldON Provides Update on Neville-Potier Portion of its Swayze Gold Project

The Property Adjoins IAMGOLD's 7.6 million ounce Côte Gold Project

Victoria, British Columbia (FSCwire) - [GoldON Resources Ltd.](#) (TSX-V: GLD) ("GoldON" or the "Company") announced today results from the recently completed drill program on the Neville-Potier Portion (the "Property") of its Swayze Gold Project.

The two-hole, 400 meter drill program completed in late November 2014 was designed to test two shallow gold targets developed from the geological mapping, prospecting, and geophysical surveying programs completed on the Property earlier last year:

Drill hole NEV14-09 was designed to undercut the Au-bearing shear-hosted quartz vein – gossan zone discovered from the 2014 mapping program. The drill hole failed to return any anomalous gold values.

Drill hole NEV14-10 was designed to test a zone of elevated chargeability at a location where a mapped lens of feldspar porphyry intrudes the largely mafic volcanic stratigraphy. The drill hole failed to intersect any significant gold values.

The Company is still awaiting assay results from drill core obtained from the geotechnical drilling program completed last fall on the Property by Trelawney Mining and Exploration Inc. ("Trelawney"), a subsidiary of IAMGOLD Corporation. Assay results will be reported once available.

The Neville-Potier property is located in an established gold district and covers a 15 kilometer swath along the Ridout Deformation Zone that has been defined as the extension of the Larder Lake-Cadillac Break. Access and infrastructure are excellent, with the Property's southern boundary located approximately 3 km north of the Côte Gold Project (NI 43-101 Indicated Resources of 7.6 million gold ounces) owned by Trelawney.

"The Neville-Potier property remains largely underexplored and the exploration work completed last year will enable us to keep the entire 6,000 hectare claim block in good standing into next year", said GoldON President, Mike Romanik. "We will now focus our attention on the high-grade Slate Falls property and drill testing of the new gold-silver-VMS exploration model we proposed last year."
