

Marksman Energy Inc.: Announces Update Regarding Private Placement and Operations

CALGARY, July 27, 2017 - [Marksman Energy Inc.](#) (TSX:MAH) (OTCQB:MKSEF) ("Marksman") announces that, further to its previous press releases, it intends to complete by August 25, 2017 a second closing of its previously announced non-brokered private placement of up to 5,000,000 units (the "Units") of Marksman at a price of \$0.08 per Unit for aggregate gross proceeds of up to \$400,000 (the "Offering").

Marksman intends to use the net proceeds of the Offering to pay interest on debt of approximately \$75,000 and up to \$325,000 will be used for participation in the drilling, completion and equipping of wells in Ohio, USA.

Completion of the Offering is subject to regulatory approval including, but not limited to, the approval of the TSX Venture Exchange Inc. The Common Shares issued are subject to a four month hold period from the date of issuance.
