Tahoe Reports Fuel Spill At La Arena Mine; Spill Fully Contained

VANCOUVER, British Columbia, April 9, 2018 /CNW/ -- Tahoe Resources Inc. ("Tahoe" or the "Company") (TSX: THO TAHO) reports a fuel spill at the La Arena mine in Peru late Friday evening, April 6th. The fuel spill occurred when a co over-fueled one of the diesel storage tanks, spilling into the containment facilities. Unfortunately, the containment drain been left open by the fuel vendor due to continuing rains. As a result, it is estimated that approximately 300 to 500 gallefuel left La Arena's containment facilities.

Upon identification of the leak, the Company immediately closed the valve and initiated our emergency response and c protocols. The Company has successfully contained the spill through the construction of dams, the placement of absorb materials and disposed of the recovered fuel in accordance with legal requirements. The Company immediately began extensive inspections of the surrounding areas from the operation. Initial inspections confirm that the spill was contained property and did not reveal any reported impact, however we continue to monitor the situation closely.

The incident was reported to the Agency for Environmental Assessment and Control (OEFA) and to the Supervisor of I Energy and Mines (OSINERGMIN) within the required 24-hour period. The surrounding communities of La Arena have notified.

OEFA was on site at La Arena on Sunday, April 8th to complete their investigation, but has not yet issued any findings, notices of violation. Production is not expected to be impacted by this event.

A full internal investigation will be completed in order to avoid and prevent future incidents. Tahoe holds itself accounta ensuring safe operations for our environment and our communities and we expect all of our employees and partners al operate to the highest standards.
