VANCOUVER, Aug. 28, 2018 - [Bear Creek Mining Corp.](#) ("Bear Creek" or the "Company") (TSXV: BCM) (BVL: BCM) has today filed a preliminary short form base shelf prospectus with the securities commissions in each of the provinces of Canada, except Quebec.

The Company is filing this Shelf Prospectus to maintain financial flexibility as it advances its flagship Corani Property but has no immediate intentions to undertake an offering.

The base shelf prospectus (the "Shelf Prospectus") has not yet become final for the purpose of the sale of any securities. When final, the Shelf Prospectus will allow Bear Creek to offer and issue up to Cdn \$300 million of common shares, warrants, subscription receipts, units, debt securities, or any combination of such securities (collectively, the "Securities") during the 25-month period that the Shelf Prospectus is effective. The Securities may be offered separately or together, in amounts, at prices and on terms to be determined based on market conditions at the time of sale, which will be set forth in a prospectus supplement to be filed.

The Securities have not been registered under the U.S. Securities Act of 1933, as amended, and may not be offered or sold in the United States absent registration or an applicable exemption from the registration requirements. This news release shall not constitute an offer to sell or the solicitation of an offer to buy nor shall there be any sale of the Securities in any State or jurisdiction in which such offer, solicitation or sale would be unlawful. Any public offering of the Securities of the Company to be made in the United States must be made by means of a prospectus containing detailed information about the Company and management, as well as financial statements.
