The discovery of the widest graphite vein found to date was made in the course of driving a new ventilation shaft at the M1 site and has continued to grow in width as the digging progresses deeper into the rock.

Such a discovery clearly shows the robust exploration potential of the M1 site. No such modern exploration has occurred in one of the worlds best crystalline graphite jurisdictions. The pictures above show the size of the vein. This vein is in the southern section of the GRID.
