CANONSBURG, April 24, 2020 - The Board of Directors of CONSOL Coal Resources GP LLC, the general partner of CONSOL Coal Resources LP (NYSE: CCR), today announced a temporary suspension of quarterly cash distributions to all unitholders due to the ongoing uncertainty in the commodity markets driven by COVID-19 pandemic-related demand decline.

"We are living in very uncertain times and the depth and breadth of demand decline is very unpredictable at this moment," said Jimmy Brock, Chief Executive Office of CONSOL Coal Resources GP, LLC. "Accordingly, we feel it is prudent to conserve cash, boost liquidity and reduce our outstanding debt. The management team has undertaken several actions at operational and corporate levels over the last few months as we seek to manage our balance sheet and liquidity. As we gain better visibility on customer demand during the next quarter, the Board of Directors will determine an appropriate level for cash distributions."

This press release is intended to be a qualified notice to nominees as provided for under Treasury Regulation Section 1.1446-4(b). Brokers and nominees should treat one hundred percent (100.0%) of CONSOL Coal Resources LP's distributions to non-U.S. investors as being attributed to income that is effectively connected with a United States trade or business. For its ownership interest, CCR has an effective annual production capacity of 7.1 million tons of high-Btu North Appalachian thermal and crossover metallurgical coal.
