Highlights

- All four holes intersected higher grade core lengths of 130 to 175 metres of 0.35% nickel.
 Higher grade mineralization of 0.35% nickel or better now intersected across a strike length of 600 metres in wes portion of Main Zone and remains open in multiple directions.
- Three of four holes were mineralized over entire core lengths of 366 to 375 metres with 0.30% nickel or better, in lengths of 24 to 72 metres of 0.4% nickel
- All four infill holes in this release were continuously mineralized from the beginning to the end of the holes within the dipping higher-grade core which varies in true thickness from 40 m to 160 m

TORONTO, Aug. 20, 2020 - Canada Nickel Company Inc. (TSXV: CNC) ("Canada Nickel" or the "Company") today an additional encouraging results from infill drilling on the Main Zone at its Crawford Nickel-Cobalt Sulphide project.

"Our infill drilling program continues to deliver outstanding results. The second higher grade resource area in the wester Main Zone identified in our previous infill release has been further confirmed by these new holes. These higher grade reareas will be the initial focus of the mine plan in the Preliminary Economic Assessment currently underway and expected completed by year-end," said Mark Selby, Chair and CEO of Canada Nickel. "We have now completed the final three in the resource update and we are currently drilling the follow up holes on the previously reported excellent PGM results for CR20-32 (three separate intersections including 2.6 g/t PGM over 7.5 metres) and will begin testing several other prospending prophysical nickel targets on the several kilometres of the Crawford structure which remain untested."

The Crawford Nickel-Cobalt Sulphide Project is located in the heart of the prolific Timmins-Cochrane mining camp in Ocanada, and is adjacent to well-established, major infrastructure associated with over 100 years of regional mining acti

Main Zone Infill Results

Infill drilling on the Main Zone continued to focus on more clearly defining and upgrading the Higher-Grade Core resour was previously defined as part of the resource estimate and dips steeply within the ultramafic unit and having a previous true thickness that varies from 40 m to 160 m.

All four infill holes contained in this release intersected thick intersections of nickel mineralization, and continue to extendefine the higher grade resource areas. Assays from the remaining 11 in-fill holes will be released over the next severa See Table 1 and Figure 1 and 2 for results.

Highlights of the drilling include:

- Infill hole CR20-48 intersected 0.31% nickel across entire core length of 368 metres
- Infill hole CR20-50 intersected 0.33% nickel across entire core length of 366 metres
- Infill hole CR20-52 returned 0.30% nickel across entire core length of 375 metres
- Higher grade mineralization >0.35% nickel has now been delineated across approximately 600 metre strike lengt westernmost end of Main Zone. See Figure 2.
- All four infill holes in this release were continuously mineralized from the beginning to the end of the holes, and fu expands dimensions of higher grade (>0.35% Ni) mineralization in the western end of mineralization of the Main 2

Next Steps

All drill results to date will be incorporated into an updated resource now expected by the end of the summer. Infill drilling for this resource update is now completed and drilling is now following up on the previously reported excellent PGM results from hole CR20-32 (three intervals including 2.6 g/t PGM over core length of 7.5 metres) and several other prospective geophysical targets on the several kilometres of the Crawford structure which remain untested on the west side of the highway.

Issuance of Options and RSUs to Independent Directors

The Company also announced today that it has issued 20,000 options ("Options") to acquire Company common shares at \$1.87 per share and 10,000 restricted share units ("RSUs") to each of its three independent directors. Assays, Quality Assurance/Quality Control and Drilling and Assay Procedures

William E. MacRae, MSc, P.Geo., a "qualified person" as defined by NI 43-101, is responsible for the on-going drilling and sampling program, including quality assurance (QA) and quality control (QC). The core is collected from the drill in sealed core trays and transported to the core logging facility. The core is marked and sampled at 1.5 metre lengths and cut with a diamond blade saw. Samples are bagged with QA/QC samples inserted in batches of 35 samples per lot. Samples are transported in secure bags directly from the Canada Nickel core shack to Actlabs Timmins, an ISO/IEC 17025 accredited lab. Analysis for precious metals (gold, platinum and palladium) are completed by Fire Assay while analysis for nickel, cobalt, sulphur and 17 other elements are performed using a peroxide fusion and ICP-OES analysis. Certified standards and blanks are inserted at a rate of one QA/QC sample per 32 core samples making a batch of 35 samples that are submitted for analysis.
