(TSXV: OCG) (OTCQX: OCGSF) (DE: MRG1) ("Outcrop S "Company") is pleased to announce that it has closed its previously announced public offering (the "Offering") of 18,09 of the Company (the "Units") at a price of \$0.25 per Unit, for aggregate gross proceeds of approximately \$4.5 million.
