VANCOUVER, May 16, 2024 - <u>Silver Viper Minerals Corp.</u> (the "Company" or "Silver Viper") (TSXV: VIPR) (OTC: VIPRF) announces that it has closed the final tranche (the "Final Tranche") of its non-brokered private placement financing (the "Offering") pursuant to the Listed Issuer Financing Exemption (the "LIFE") of National Instrument 45‑106 - Prospectus Exemptions ("NI 45-106") announced on April 4, 2024. The Final Tranche was comprised of 2,638,000 units of the Company (the "Units") issued at a price of \$0.10 per Unit for aggregate gross proceeds of \$263,800. In total, the Company raised \$2,376,900 pursuant to the Offering, having previously closed a tranche on April 12, 2024, that raised an aggregate of \$2,113,100.

Each Unit consists of one (1) common share of the Corporation (each, a "Share") and one-half of one (1) common share purchase warrant (each whole warrant, a "Warrant"). Each Warrant will entitle the holder to purchase an additional Share (each, a "Warrant Share") at a price of \$0.15 per Share for a period of thirty-six (36) months from its date of issue. The Warrants will be governed by the terms and conditions set forth in the certificates representing the Warrants.

The Offering was completed pursuant to the listed issuer financing exemption under Part 5A of National Instrument 45-106 - Prospectus Exemptions, accordingly, the securities issued in the Offering are not subject to a hold period in accordance with applicable Canadian securities laws. Prospective investors should read this Offering Document before making an investment decision.

The Company intends to use the net proceeds from the Offering for resource expansion and exploration drilling at the La Virginia Project as well as surface exploration including mapping and sampling. Net proceeds from the Offering will also be used for the final US\$200,000 option payment on its La Virginia Project due in June 2024, and for general corporate purposes.

In connection with the closing of the Final Tranche, Silver Viper will pay a finder's fees of \$420 to Haywood Securities Inc. In total, the Company will pay \$125,406 in finder's fees in connection with the Offering, having previously closed on April 12, 2024, that resulted in payment of \$124,986 in finder's fees.
