

Golden Queen Mining Co. Ltd. Completes \$8,000,000 Private Placement with Gammon Gold Inc.

VANCOUVER, June 1 /[CNW](#)/ - [Golden Queen Mining Co. Ltd.](#) is pleased to announce that it has completed a private placement of 5,000,000 units at a price of \$1.60 per unit for total proceeds of \$8,000,000. The sole investor in the private placement was [Gammon Gold Inc.](#) As a result of the private placement, Gammon Gold holds approximately 5.3% of the issued common shares of Golden Queen or approximately 7.5% on a fully diluted basis.

Each unit consists of one common share, one quarter of one Class A Warrant, and one quarter of one Class B Warrant. Each Class A Warrant entitles Gammon Gold to purchase a common share of Golden Queen at a price of \$1.75 for a period of 18 months from the closing date. Each Class B Warrant entitles Gammon Gold to purchase one common share of Golden Queen at a price of \$2.00 for a period of 18 months from the closing date.

Subject to certain conditions, Gammon Gold was granted the right to participate in future financings to maintain its equity position in the Company.

Net proceeds from the private placement will principally be used for expenses associated with the ongoing development of the Company's Soledad Mining project and for general working capital.
