The Global Compact is a policy platform and practical framework for companies that are devoted to sustainability and responsible business practices. Its objective is to align business operations and strategies with ten universally accepted principles in the areas of human rights, labour, environment and anti-corruption. With less than 2% of participants in the mining sector, SEMAFO is among industry leaders with its support of this global initiative, which was launched by the United Nations in July 2000.

'We are proud to be a leader for corporate social responsibility in West Africa,' said Benoit La Salle, SEMAFO's President and Chief Executive Officer. 'We remain focused on creating value for the communities and countries in which we operate. Through our existing corporate social responsibility programs and now our commitment to the United Nations Global Compact, we are paving the way to effect positive long-term change in West Africa.'

As a strong proponent of corporate social responsibility ('CSR') activities, in February 2011, SEMAFO began its broadcast of 'Together for a Better Society', a 30-minute weekly national radio campaign in Burkina Faso. A total of 52 episodes were broadcasted in partnership with the Government of Burkina Faso and local organizations. These radio segments raise awareness and provide important information to favour development around social, economic and environmental issues.

'We would like to express our gratitude towards SEMAFO, a company that in its mining operations and its commitment to social responsibility, is the corporate role model our country needs,' said Luc Adolphe TIAO, Prime Minister of Burkina Faso.

SEMAFO's commitment to corporate social responsibility extends to both SEMAFO Energy and Fondation SEMAFO. The Corporation has contributed its savoir-faire to assist SEMAFO Energy in the effort to create consortiums that will work closely with host country governments to increase their energy resources. These efforts were recognized earlier this month at the 2012 Africa Mining Congress in Livingstone, Zambia, where SEMAFO was presented with the Green Energy Award.

In 2011, SEMAFO also continued its important corporate philanthropy program of donating up to 2% of its net income to support Fondation SEMAFO in the realization of vital projects. - Collection, delivery and distribution of donated items, including medical supplies, school and office supplies, books, clothing and other miscellaneous items, filling 44 freight containers since 2009
- Revenue-generating programs, which to date have benefited thousands of Burkinabe and Nigeriens:
 - Production and international marketing of Shea products in Burkina Faso
 - Production and improved processing of sesame for international markets
 - Development of the paprika industry in Burkina Faso and Niger
 - Installation of multifunctional platforms to power devices such as grain mills, pumps and generators, which aid in the creation of small businesses and promote the empowerment of local populations
