

# Crosshair Energy Corporation: Files Technical Report for Bootheel

VANCOUVER, 03/05/12 - [Crosshair Energy Corporation](#) (NYSE Amex: CXZ) (TSX: CXX) ('Crosshair' or the 'Company') is pleased to announce that it has filed on SEDAR, at [www.sedar.com](#), a National Instrument 43-101 Technical Report entitled 'Technical Report on the Bootheel Project for Crosshair Energy Corp. and The Bootheel Project LLC' and dated February 27, 2012 (the 'Report'). The Report is with respect to Crosshair's Mineral Resource estimate on the Bootheel Property, in southern Wyoming, the results of which were announced in a January 19, 2012 press release. The estimate includes a total Indicated resource of 1.48 million pounds of uranium oxide (2.07 million tons at 0.036% eU3O8), using a grade thickness (GT) cut-off of 0.15 %-ft. The estimate also includes a total Inferred resource of 3.13 million pounds of uranium oxide (3.99 million tons at 0.039% eU3O8), using a grade thickness (GT) cut-off of 0.15 %-ft. There are no material differences between the results announced in the press release dated January 19, 2012 and the results in the Report.

Stewart Wallis, P.Geo., President and CEO of Crosshair and a Qualified Person as defined by NI 43-101, has reviewed and approved the technical information contained in this news release. Further information regarding the Bootheel Property can be found in the Report.
