

Standard Graphite Retains Public Relations Consultant

VANCOUVER, 03/15/12 - [Standard Graphite Corp.](#) (TSX VENTURE: SGH) (the "Company") reported that it has entered into a consulting agreement to retain G2 Consultants Corp. of Vancouver, B.C., to provide financial public relations services. G2 Consultants will assist the Company in expanding its profile and conveying the Company's key messages to the investment community beyond the Company's existing investor base.

The options vest over a period of one year pursuant to TSX Venture Exchange policies.
