He has also been a director of the Makit Hardware Cooperative and ran his own successful tax practice for six years. Mr Fromson is a member of the Australian Institute of Company Directors, a Certified Practising Accountant and a Chartered Company Secretary.

Following its takeover of the Laverton Gold Operations last year, Focus has also recently bolstered its group accounting team with the appointment of Krishna Kulshreshtha as Group Financial Controller. Prior to joining Focus, Mr Kulshreshtha was the Financial Controller & Joint Company Secretary for Rey Resources Ltd and previously Finance Manager-Group Reporting, Tax & Treasury at Anvil Mining Ltd.

Mr Baird said he would like to thank Mr Grygorcewicz for all his hard work in being a part of Focus Minerals' growth over the past six years. 'We wish him well with his future ventures,' he said.

Gold is processed at Focus' 1.2Mtpa processing plant, Three Mile Hill, which is adjacent to the town of Coolgardie. Focus also operates, through its 81.57% majority shareholding in Crescent Gold, the Laverton Gold Project, located 250km northeast of Kalgoorlie in Western Australia. Laverton comprises a significant portfolio of large scale open pit mines, with ore being processed under an OPA at the nearby Barrick Granny Smith mill.
