LONDON, UNITED KINGDOM and TORONTO, ONTARIO -- (Marketwire - July 13, 2012) - [Minera IRL Limited](#) ("Minera IRL" or the "Company"), (TSX:IRL) (AIM:MIRL) (BVLAC:MIRL) the Latin America gold mining company, announces that it has filed and obtained a receipt for a final short form base shelf prospectus with the securities regulatory authorities in each of the Provinces of Canada, other than Quebec, further to its filing of a preliminary base shelf prospectus previously announced on May 25, 2012. This final base shelf prospectus will allow the Company to make offerings of ordinary shares, debt securities, warrants to purchase ordinary shares, warrants to purchase debt securities, and securities convertible into or exchangeable for ordinary shares (collectively, the "Securities") or any combination thereof up to an aggregate initial offering price of CAD\$80,000,000 during the 25-month period that the final short form base shelf prospectus, including any amendments thereto, remains effective. Securities may be offered separately or together, in amounts, at prices and on terms to be determined based on market conditions at the time of sale and set forth in an accompanying shelf prospectus supplement and, subject to applicable regulations, may include 'at-the-market' transactions, private placements, public offerings or strategic investments. Unless otherwise specified in a shelf prospectus supplement, the net proceeds from the sale of the Securities will be used for general corporate purposes including capital expenditures and working capital. The Company has no immediate plans to issue securities covered by the shelf prospectus.
