Cabrita has resigned as President and Chief Executive Officer of the Corporation to pursue other business opportunities; however continues his position as a Director of the Corporation. Dr. Wenshan Zhang, Chairman of SFX board of directors, has been appointed, on an interim basis, as President and Chief Executive Officer of the Corporation to fill the vacancy resulting from the resignation of Mr. Cabrita.
