LONDON, UNITED KINGDOM -- (Marketwire - Dec. 16, 2010) - [Crew Gold Corporation](#) ("Crew") (TSX:CRU) (OSLO:CRU) is pleased to announce that it has received a final order from the Superior Court of Yukon approving the plan of arrangement under the Business Corporations Act (Yukon) to effect the previously announced acquisition of all of the issued and outstanding common shares of Crew (not already owned by [Nord Gold N.V.](#) and Nord Gold (Yukon) Inc.).

The closing of the plan of arrangement transaction is expected to occur after the satisfaction and/or waiver of all conditions precedent to the plan of arrangement, the date of which will be announced shortly.
