

# Virginia Mines Inc.: Closing of the \$2.5 M Flow-Through-Share Private Placement

QUÉBEC CITY, QUÉBEC -- (Marketwire - Nov. 16, 2012) - [Virginia Mines Inc.](#) ("Virginia") (TSX:VGQ) confirms the closing of the private placement announced on October 26, 2012, which consisted of the issue of 142,857 flow-through common shares ("Flow-Through Shares") at a price of \$17.50 per share, which represents a 71% premium to the 10-day volume weighted average trading price of the common shares of Virginia on the Toronto Stock Exchange for the period ending November 15, 2012, resulting in gross proceeds of CA\$2,499,997.50. Laurentian Bank Securities Inc. acted as the agent for the offering and was paid a cash fee equal to 6% of the gross proceeds.

The Flow-Through Shares are subject to a four-month hold period in Canada.

Proceeds from the offering will be used to fund exploration work on Virginia's numerous projects.
