

# Aurora Oil & Gas Limited Announces Proposed Offering of Senior Notes

PERTH, Australia, July 26, 2012 /CNW/ - [Aurora Oil & Gas Limited](#) (TSX: AEF) (ASX: AUT) today announced plans for its wholly-owned US-based subsidiary, Aurora USA Oil & Gas, Inc. (the "Issuer") to commence, subject to market and other customary conditions, a private placement of US\$100 million aggregate principal amount of 9.875% senior unsecured notes due in 2017 (the "Additional Notes"). The Additional Notes will be a follow-on offering to the Issuer's US\$200 million aggregate principal amount of 9.875% senior unsecured notes issued on February 8, 2012 (the "Existing Notes"), and will form a single series of debt securities with the Existing Notes. The Additional Notes will be issued as senior unsecured obligations of the Issuer, and will be guaranteed by Aurora and each of the subsidiaries of the Issuer. The Issuer intends to use net proceeds from the proposed Additional Note offering to fund capital expenditures for development of its holdings in the Eagle Ford shale trend (together with other sources of liquidity) and for other general corporate purposes, including financing potential future acquisitions of oil and natural gas interests in its core areas.

The Additional Notes to be offered will not be registered under the U.S. Securities Act of 1933, as amended (the "U.S. Securities Act"), and may not be offered or sold in the United States absent registration or an applicable exemption from registration requirements. The Additional Notes are being offered only to qualified institutional buyers in the United States in accordance with Rule 144A under the U.S. Securities Act and to certain non-U.S. persons outside the United States in compliance with Regulation S under the U.S. Securities Act. In Canada, the Additional Notes will be offered and sold on a private placement basis in certain provinces of Canada to certain accredited investors.
