A Graduation from TSX Venture Exchange

TORONTO, Nov. 28, 2012 - The Toronto Stock Exchange announced today in the Daily Bulletin that the shares of [PMI Gold Corporation](#) (TSXVN:PMV) will graduate to trade on TSX at the open of trading on Friday, November 30, 2012. The ticker symbol will remain "PMV" and the CUSIP number will remain 730153 20 2. The company will be removed from the S&P/TSX Venture Composite Index after the close of trading on Thursday, November 29, 2012.

PMI Gold is also a constituent of the S&P/TSX Venture Select Index. The company will be removed from this index effective after the close of Thursday, December 6, 2012, at which time it will be listed on TSX.

The company is also a constituent of the S&P/TSX Venture 30 Index. According to methodology, it will remain in this index while trading on TSX until the next semi-annual review of the index in February, 2013.
