

# Sacre-Coeur Minerals, Ltd. Closes Private Placement

Vancouver, British Columbia CANADA, December 06, 2012 /FSC/ - [Sacre-Coeur Minerals Ltd.](#) (SCM - TSX Venture, S5N - FWB), (the "Company") today announced the closing of an additional small, non-brokered private placement which has raised gross proceeds of CAD \$187,200. Under the terms of the private placement, the Company has issued 1,248,000 common shares (the "Shares") at CAD \$0.15 per Share. The Company issued 99,840 finders' shares (the "Finders' Shares"). The Shares and Finders' Shares are subject to a 4-month hold period in Canada expiring April 7, 2013. Following this issue the Company will have 59,316,433 shares issued and outstanding, and 70,004,703 shares fully diluted.

It is the intention of the Company to minimize or avoid additional equity issues, and to rely to the extent possible on production revenue to finance its programs going forward. However, the Company was not able to accommodate a number of supporters within the limits, including over-allotment, of its last private placement, which closed in October 2012. For this reason, and to assist with funding the legal and other fees in connection with its gold participating bond issue announced November 7, 2012, the board has elected to proceed with this further small issue.

Proceeds from the private placement will be used for general corporate purposes, and for expenses related to the bond issue which is expected to close before the Christmas holidays.

## About Sacre-Coeur

The Company is engaged in the acquisition, exploration, development, and production of properties for gold, metals and diamonds in South America, initially focussing on exploration and production of gold from its properties in Guyana. The Company presently holds 100% interest in approximately 850 sq. km of mineral properties in Guyana, including the Million Mountain Property which hosts an NI 43-101 compliant hard-rock resource of 12,119,285 tonnes grading 1.0 g/t Au Measured, and 2,175,278 tonnes grading 0.9 g/t Au Indicated for a total 451,000 tr oz Au combined.
