The shareholders of [Hana Mining Ltd.](#) (TSXVN:HMG) have approved the Plan of Arrangement whereby the company will be acquired by Cupric Canyon Capital LP and Cuprous Capital Ltd. Shareholders of Hana Mining will receive \$CDN0.82 cash per share held.

Hana Mining will be removed from the S&P/TSX Venture Composite and Venture Select Indices after the close of Wednesday, January 9, 2013.
