[Metals Creek Resources Corp.](#) (the "Company", TSXV: MEK) is pleased to announce that it has received approval from the TSX Venture Exchange to extend the term of 10,484,500 share purchases warrants (the "Warrants"), which were set to expire on February 2, 2013, by twelve (12) months. The Warrants were issued as part of a private placement completed by the Company on February 4, 2011. Each Warrant is exercisable into one Common Share of the Company at a price of \$0.45 per share. The new expiry date of the Warrants is February 2, 2014. All other terms of the Warrants will remain unchanged.
