VANCOUVER, Jan. 15, 2013 - [Parkside Resources Corporation](#) (the "Company") is pleased to announce that further to its news release dated December 31, 2012, the Company has paid an additional finder's fee of \$1,050 to Macquarie Private Wealth Inc. and issued 10,500 finder's warrants and paid an additional finder's fee of \$714 to Canaccord Genuity Corp. and issued 5,950 finder's warrants (collectively, the "Finder's Warrants"). Each Finder's Warrant is exercisable to purchase one common share at a price of \$0.13 until July 11, 2015.
