# Wildcat Silver completes acquisition of Riva Gold

VANCOUVER, May 6, 2013 - Wildcat Silver Corporation (TSX: WS) ("Wildcat") and Riva Gold Corporation (TSX-V: RIV) ("Riva") are pleased to announce the completion of the acquisition of Riva by Wildcat as announced on March 4, 2013. A definitive agreement was entered into and announced on April 4, 2013 providing for the acquisition by Wildcat of all the outstanding common shares of Riva in consideration for one common share of Wildcat for 4.7 common shares of Riva. The transaction was approved by the Riva shareholders at the annual general and special meeting held on May 3, 2013.

With the acquisition now complete, shares of Riva are no longer trading and will be delisted from the TSX Venture Exchange.

#### **About Riva**

Riva was a Canadian-based mineral exploration company that was focused on identifying and developing new discoveries. Riva was assessing its strategic alternatives and evaluating potential opportunities with the objective of taking a staged approach to its activities.

#### **About Wildcat**

Wildcat is a Canadian mineral exploration company focused on the development of its 80% owned Hermosa silver project located in Santa Cruz County, Arizona. The project currently has a preliminary economic assessment completed which estimates average annual production of over 15 million ounces of silver for the first five years and a 16 year mine life, making it one of the largest undeveloped silver projects in the USA. Hermosa's measured and indicated mineral resource consists of 194 million tonnes averaging 37.7 grams per tonne silver for a total of 236 million ounces of silver and an inferred mineral resource of 80 million tonnes averaging 30.9 grams per tonne silver for a total of 79 million ounces of silver as announced in the August 9, 2012 press release.
