

Detour Gold Completes C\$176 Million Bought Deal Offering

TORONTO, ONTARIO -- (Marketwired - June 11, 2013) - [Detour Gold Corporation](#) (TSX:DGC) ("Detour Gold" or the "Company") today announced that it has completed its previously announced public offering (the "Offering") of 20,125,000 common shares ("Common Shares"), pursuant to its short form prospectus dated June 3, 2013, raising gross proceeds of C\$176,093,750. The underwriters, led by BMO Capital Markets, purchased all of the 2,625,000 Common Shares available for issuance pursuant to the exercise of their over-allotment option, in addition to the 17,500,000 Common Shares that the underwriters initially agreed to purchase. As of today's date and factoring the Common Shares issued pursuant to the closing of the Offering, Detour Gold has 138,018,791 Common Shares issued and outstanding.

The Company intends to use the net proceeds of the Offering for working capital during the ramp-up of the Detour Lake mine and for general corporate purposes.

The securities offered have not been registered under the U.S. Securities Act of 1933, as amended, and may not be offered or sold in the United States absent registration or any applicable exemption from the registration requirements. Detour Gold is an emerging mid-tier gold producer in Canada. The Detour Lake open pit mine is expected to produce an average of 657,000 ounces of gold annually over a period of 21.5 years. Detour Gold's shares trade on the Toronto Stock Exchange under the trading symbol DGC.
