The shareholders of [Rainy River Resources Ltd.](#) (TSX:RR) have accepted a takeover bid from [New Gold Inc.](#) (TSX:NGD). Rainy River shareholders will receive either one-half share of New Gold or \$CDN3.83 cash for each share held. Rainy River will be removed from the S&P/TSX Global Mining, Global Gold and SmallCap Indices after the close of trading on Wednesday, July 31, 2013.
