Jim Engdahl, President and CEO of Star Uranium said, "We are very pleased to add Mr. McKnight to the board of directors of Star Uranium. His experience and expertise will be of considerable value to the board and will keep the board well positioned to guide Star Uranium in its future endeavors."

The Corporation also announces that Mr. Kulvinder (Kal) Matharu has resigned as director of the Corporation for personal reasons, effective September 3, 2013. Mr. Jim Engdahl, President and Chief Executive Officer of the Corporation, would like to thank Mr. Matharu for his past service to the Corporation.
