

Canada Carbon Acquires Mining Claims Adjacent to Miller Property

VANCOUVER, BRITISH COLUMBIA--(Marketwired - Oct 9, 2013) - **Canada Carbon Inc. (TSX VENTURE:CCB) (the "Company")** announces that it has entered into a mining claims purchase and transfer agreement (the "**Agreement**") with an arm's length Vendor ("**Vendor**") pursuant to which the Company will purchase 14 mining claims and 10 pending claims (collectively, the "**Claims**") contiguous to the Company's historic Miller Graphite Mine (the "**Miller Property**"). The Claims are located [**80 kilometres ("km") west of Montréal near Grenville, Québec.**] With this new land acquisition, the Miller Property will now cover 26.2 km² of prospective graphite potential.

Pursuant to the Agreement, and subject to the prior approval of the TSX Venture Exchange, the Company has agreed to pay \$25,000 in cash and to issue 250,000 common shares in the capital of the Company to the Vendor.
