As a huge supporter of history and veteran pilot, Bill was also Chairman of the Canadian Warplane Heritage Museum and a member of the Great War Flying Museum. "Through his intelligence and dignity, Bill made the world a much better place. He was a true gentlemen who deeply touched all of us who knew him", said Don Robinson. "Eastmain was privileged and honoured to have had Bill as one of our family. We will miss his charm and warmth".
