

# Eastmain Appoints Serge Bureau to New Advisory Board Position

As part of Barrick's Business Development Group for the Peru Region, Mr. Bureau was also involved in supervising technical projects at the company's Pierina Mine. Additional roles for Barrick included Director Capital Projects for Russia &#8208; East Asia and Manager of Technical Services for the feasibility study at Pueblo Viejo.

Since 2008 Mr. Bureau has been involved as President and CEO of Crevier Minerals Inc. a private company controlled by MDN Inc. and Niobec Inc., a subsidiary of IAMGold Corp.. Crevier Minerals Inc. owns an advanced&#8208;stage tantalum&#8208;niobium deposit.
