Toronto, Ontario -- (Newsfile Corp. - March 5, 2014) - [Solvista Gold Corporation](#) (TSXV: SVV) (OTCQX: SVVZF) ("Solvista" or the "Corporation") is saddened to announce that Mr. Gary P. Barket, a member of Solvista's board of directors, died on February 25, 2014 in Little Rock, Arkansas.

Mr. Barket served as a director since the Corporation's inception in January 2011 and played an integral role in Solvista's development and going public transaction. Mr. Barket had a long and distinguished career as an attorney in private practice dating back to 1972 with an emphasis on securities, business transactions and litigation. Mr. Barket also served as a Chairman and was a member of the Little Rock Port Authority Board of Directors from 1993 to 2006. He was also chairman of the Corporation's Corporate Governance and Nominating Committee and a member of the Audit Committee.
