VANCOUVER, BRITISH COLUMBIA -- (Marketwired - March 17, 2014) - [Zincore Metals Inc.](#) (TSX:ZNC) (LMA:ZNC) ("Zincore" or the "Company") is pleased to announce a non-brokered private placement of up to 6,379,040 units (the "Units") at a price of C\$0.135 per unit, to raise gross proceeds of up to C\$861,000. Each Unit will be comprised of one common share and one-half of a common share purchase warrant. Each whole warrant will entitle the holder to purchase one common share at C\$0.19 for up to 24 months. The Company may pay a finder's fee equal to a cash payment of 6% of gross proceeds.

The net proceeds of the offering will be used for general corporate purposes and all securities issued with respect to this offering will be subject to a four month hold period in accordance with applicable Canadian securities laws. The closing of the offering is subject to receipt of all necessary regulatory approvals including that of the Toronto Stock Exchange.
