

# Perseus Mining Limited: Operations at Edikan Gold Mine Resumed

PERTH, WESTERN AUSTRALIA -- (Marketwired - April 16, 2014) - [Perseus Mining Limited](#) ("Perseus" or the "Company") (TSX:PRU) (ASX:PRU) is pleased to advise that ore processing operations resumed at its Edikan Gold Mine in Ghana at approximately 5.00pm GMT on Wednesday April 16, 2014, seven days after a fire occurred in the cyclone nest of the plant while undergoing routine maintenance.

Perseus's Managing Director Jeff Quartermaine said that, following a thorough investigation into the cause of the fire and the Company's response, work commenced on repairing fire damage.

"The effort put in by our on-site team to assess and carry out the repair work was impressive and the fact that we were able to resume operations, as forecast, within seven days is a real credit to all of those involved," Mr Quartermaine said.

"We have learned a lot of very valuable lessons and the cost of repairs has been relatively modest."
