

# Eldorado Gold Corporation: Announces Election of Directors

VANCOUVER, May 2, 2014 - [Eldorado Gold Corp.](#) ("Eldorado" "the Company" or "We") (TSX:ELD) (NYSE:EGO), in accordance with Toronto Stock Exchange requirements, announced the voting results for the election of its Board of Directors at the Company's Annual Meeting of Shareholders held on May 1, 2014 in Vancouver, British Columbia. The director nominees as listed in the Management Proxy Circular dated March 20, 2014 were elected as directors of Eldorado at the meeting as follows:
