

# Sarama Resources announces closing of subsequent financing bringing total funds raised to C\$3.15M

VANCOUVER, July 4, 2014 /CNW/ - [Sarama Resources Ltd.](#) (the "Company" or "Sarama") is pleased to announce that on July 4, 2014 it closed its further private placement (the "Subsequent Financing"), which was announced June 20, 2014. The Company has raised aggregate gross proceeds of C\$270,000 through the issue of 1,800,000 units and when combined with the recent private placement completed June 18, 2014 brings total funds raised to C\$3,148,080. Each unit was priced at C\$0.15 and consisted of one common share and one half of one common share purchase warrant. Each whole share purchase warrant is exercisable into one common share for a period of two years at a price of C\$0.20 per share.

The securities issued in connection with the Subsequent Financing will be subject to a four-month and one day hold period expiring on November 5, 2014 in accordance with relevant Canadian Securities Laws.

The proceeds of the recent private placement that was completed June 18, 2014 and the Subsequent Financing, will be used principally to fund diamond drilling at the Company's properties in Liberia, oxide-focused air core drilling at the Company's South Houndé Project in Burkina Faso and an air core scout drilling program at the Company's Kandiolé Sud permit, which is proximal to Papillion Resources' Fekola Gold Project and the Merrex Gold/IAMGOLD Diakha discovery, in Mali. Funds will also be used for general working capital purposes.
