

# Canadian Platinum Corp. Shareholders Elect New Board Members; New Management Appointed

CALGARY, ALBERTA--(Marketwired - Jul 31, 2014) - [Canadian Platinum Corp.](#) ("CPC" or the "Company") (TSX VENTURE:CPC) is pleased to announce the election of two new members to the Board of Directors at the Annual General and Special Meeting of Shareholders held July 30, 2014 in Calgary, AB.

Mr. James Engdahl and Mr. Douglas Billingsley are the two new board members elected at the meeting. They join incumbent members Gary Billingsley and Mason Douglas re-elected by the Company's shareholders. Former board members Todd Montgomery, Brent Walter and Randy Ludwar did not stand for re-election.

Mr. Engdahl got his business and finance background working for many years in banking, where he last served as a Vice President of Barclays Bank of Canada.

Mr. Billingsley is currently a Partner with Hong Kong based, Battalion Partners LLC. Battalion is a business advisory and consulting firm that specializes in working with companies to prepare and structure them to successfully attract investment capital.

Throughout his career Mr. Billingsley has held numerous executive positions (CEO, COO, CFO, SVP Corporate Planning, VP Marketing & VP Product Development) in large financial services and manufacturing organizations. His experience spans private and public companies as well as successfully starting and growing his own businesses. Coming from a mining family, he is very familiar with the mining industry, and has served on the boards of several publicly traded junior mining companies.

Subsequent to the Annual General and Special Meeting, Gary Billingsley was appointed by the Board to the position of President and CEO and Mason Douglas was appointed Chairman of the Board. Mr. Billingsley comments, "I want to thank Todd, Brent and Randy for their dedicated service to the Company since its inception. Todd Montgomery has always had extraordinary vision in project selection and has left a solid base for the new management to build on, which is critical in this challenging market. Canadian Platinum will continue to focus on platinum and base metals."
