VANCOUVER, BRITISH COLUMBIA--(Marketwired - Sep 5, 2014) - **Levon Resources Ltd.** ("Levon" or "the Company") (TSX:LVN)(OTCQX:LVNVF)(BERLIN:LO9)(FRANKFURT:LO9) announces that it has come to the Company's attention that there was an error in a number in the news release which the company issued on September 3, 2014. The release incorrectly stated that the new resource estimate included a 57% increase in the indicated silver resource at the Company's Cordero Project over the Company's July 2012 resource estimate. The correct percentage is approximately 34%.
