HOUSTON, TX / ACCESSWIRE / December 12, 2014 / [Holloman Energy Corporation](#) (HENC.OB) announces that its farmout partner has initiated the process of acquiring the required permits and heritage clearance in support of the upcoming drilling campaign for the Petroleum Exploration License ("PEL") 444 block located on the western flank of the Cooper/Eromanga Basin in the state of South Australia, Australia.

The Company has previously announced that its farmout partner has identified eight drilling locations based on the ranking and risking of multiple targets in the Birkhead, Namur and Hutton horizons. The permits and heritage clearance are expected to be completed within the next 60 days.
