

ElanOre Resources sends spodumene concentrate sample to Fancy Mining Industry Co., Ltd.

Toronto - [Jourdan Resources Inc.](#) (TSX-V: JOR) (“JOURDAN” or the “Company”) (www.jourdan.ca) is pleased to announce ElanOre Resources Inc. (“ElanOre”), a Canadian private company in which Jourdan holds 6 million shares (24.9%) has shipped a concentrate sample to Fancy Mining Industry Co., Ltd (“Fancy”) for testing.

On August 22, 2013, Jourdan announced that it had optioned to ElanOre its Vallée Lithium Property, composed of 17 claims, located 100 km northeast of Rouyn-Noranda and 45 km north of Val d’Or, in the Province of Quebec, Canada. On November 6, 2014, Jourdan announced the agreement between ElanOre and Fancy naming ElanOre as the exclusive agent for Fancy Mining for all spodumene sourced from the province of Quebec, with Fancy Mining acting as exclusive agent for sales of spodumene from ElanOre to China, South East Asia, and India.

If Fancy reports positive test results and supply can be secured, orders of 150,000 tonnes of spodumene concentrate are expected to be traded as part of the agreement between ElanOre and Fancy.
