

Completes Private Placement - Erin Ventures Inc.

Victoria - [Erin Ventures Inc.](#) (“Erin” or the “Company”) [TSX-Venture: EV] announces today that it has completed its private placement announced on December 2, 2014 and updated January 16, 2014 for total gross proceeds of \$544,500.00.

The Company raised CAD\$147,500.00 by closing the second tranche of its non-brokered private placement. Pursuant to the terms of the private placement, Erin issued 2,950,000 units at a price of \$0.05 per unit (the “Units”). Each Unit consists of one common share of the Company and one common share purchase warrant (the “Warrant”). Each Warrant entitles the holder to purchase one common share of the Company exercisable at \$0.15 for the first two years and with an exercise price of \$0.30 in the third year.

All securities issued in connection with this second tranche offering are subject to a four-month-and-one-day hold period expiring on May 31, 2015, pursuant to applicable securities legislation and the rules of the TSX Venture Exchange.

This offering was carried on a private placement basis pursuant to prospectus exemptions of applicable securities laws and is subject to final acceptance by the TSX Venture Exchange.

The net proceeds from this placement will be used to fund the company's exploration activities on its Piskanja, Serbia property and for working capital purposes.
