

Calgary, Alberta (FSCwire) - [Morro Bay Resources Ltd.](#) (the "Morro Bay" or the "Company") (TSX-V: MRB) is pleased to announce it has closed the second tranche (the "Second Tranche") of the non-brokered private placement (the "Private Placement") announced April 6, 2015. The Second Tranche consists of the issuance of a total of 1,530,000 Units at a price of \$0.05 per unit for gross proceeds of \$69,000. A total of 5,120,000 Units for gross proceeds of \$248,500 has currently being placed from the First and Second Tranches in the Private Placement. The Private Placement remains open for further subscriptions.

Each Unit is comprised of one common share (the "share") of the Company and one common share purchase warrant ("Warrant"). As a result, the closing on the Second Tranche consists of the issuance of 1,530,000 shares and 1,530,000 Warrants. Each Warrant will be exercisable for one common share of the Company for a period of 24 months from the closing date of their issuance at an exercise price of \$0.05 per share for the first 12 months and at an exercise price of \$0.10 for the second 12 months. The Warrants will not be listed for trading.

In connection with the Private Placement, the Company may pay finder's fees to arm's-length third parties consisting of: (i) cash commission of up to 10% of the gross proceeds of the Offering; and (ii) broker warrants ("Broker Warrants") in an amount up to 10% of the total number of Units under the Offering. Each Broker Warrant is on the same terms the Warrants described above. As a result of the Second Tranche of subscriptions a total of 10,000 Broker Warrants were issued.

Carl von Einsiedel, VP Exploration and a member of the Board of Directors of Morro Bay, subscribed for 850,000 Units.

Proceeds from the Private Placement will be used for the exploration work at the Peñoles property and for general corporate purposes.

The Private Placement is subject to TSX Venture Exchange approval. The securities issued in the Private Placement will be subject to a hold period of four months plus one day following the issue date, under applicable Canadian securities legislation.

As a result of the recent issuance under the Private Placement, Morro Bay currently has 83,565,233 shares outstanding and 6,062,000 Warrants outstanding.
