

Stans Energy Corporation Legal Update

Toronto, Ontario (FSCwire) - [Stans Energy Corp.](#) (TSX-V: HRE, OTCQX: HREEF) (‘Stans’ or ‘The Company’) announces that an appeal date to the written ruling of the Moscow City Arbitrazh Court (the “Court”) has been set. The appeal will be heard on July 20, 2015.

As reported on June 2, 2015, the Court set aside the US\$118 million award of the Moscow Chamber of Commerce and Industry (the “MCCI”) on procedural grounds, not on the merits of the case. The Company continues to seek recognition and enforcement of the MCCI award before the Ontario Superior Court of Justice. Due to the addition of new legal representation from Torys LLP to the case file, a delay in the July 21, 2015 hearings has been requested for further preparation. An update will be issued once a date is set by the Ontario Superior Court of Justice.

About Stans Energy

[Stans Energy Corp.](#) is a resource development company focused on advancing rare earth and specialty metals properties in areas of Central Asia and Russia. Stans acquired the past producing rare earth mine, Kutessay II, in the Kyrgyz Republic in 2009. Since that time the Government of the Republic of Kyrgyzstan took expropriatory actions against the Company’s interests in that country. Subsequently Stans Energy applied to international arbitration to resolve the conflict. On June 30, 2014, Stans Energy was awarded US\$118 Million by the Arbitration Tribunal at the Moscow Chamber of Commerce and Industry. On October 24, 2014, Stans Energy obtained a Mareva Injunction arresting 47 million shares of Centerra Gold (TSX: CG) as security in this matter, which was subsequently removed by the Ontario Divisional Court. Stans has filed notice to appeal that decision. Stans is seeking recognition by the Ontario Superior Court of Justice of the MCCI award to collect US\$ 118 Million from the Kyrgyz Republic.
