

Wellington, New Zealand--(Newsfile Corp. - August 26, 2015) - [New Zealand Energy Corp.](#) (TSXV: NZ) (OTCQX: NZERF) ("NZE" or the "Company") has released the results of its second quarter ended June 30, 2015. Details of the Company's financial results are described in the Condensed Consolidated Interim Financial Statements for the period ended June 30, 2015 and Management's Discussion and Analysis which are available on the Company's website at www.newzealandenergy.com and on SEDAR at www.sedar.com.

The net loss for the three-month period ended June 30, 2015 was \$1,222,855 (including non-cash charges of \$376,590 for depreciation and \$508,235 for impairment) compared with a loss for the second quarter of 2014 of \$10,164,654 (which included non-cash charges of \$867,327 for depreciation and \$9,331,014 for impairment). The Company realized a loss per share for the three-month period ended June 30, 2015 of \$0.01 (2014: \$0.06).
