TORONTO, Dec 21, 2015 - [Thundermin Resources Inc.](#) (TSX VENTURE:THR) ("Thundermin") announces that the shareholders of Thundermin have approved the merger by way of an amalgamation with a subsidiary of [Rambler Metals and Mining Plc](#) (TSX VENTURE:RAB) on the terms as disclosed in the information circular of Thundermin dated November 9, 2015 (the "Merger"). The information circular is filed on SEDAR at the profile of Thundermin at [www.sedar.com](http://www.sedar.com). The Merger is expected to close on or before December 31, 2015. Thundermin will, on completion of the Merger, become the wholly owned subsidiary of Rambler, and Rambler will continue to trade on the TSX-V under the symbol "RAB". The consolidated group will carry on the business of Rambler as a mining, exploration and development company.
