

OTTAWA, ONTARIO--(Marketwired - Dec 23, 2015) - [Majescor Resources Inc.](#) ("Majescor" or the "Corporation") (TSX VENTURE:MJX) announces the sale of the Corporation's remaining 0.5% Gross Sales Royalty (the "Royalty") on the Brauna diamond property to a Director of the Corporation (the "Purchaser").
